## More LEARNING

Nearly 100 Columbus-area preschoolers and toddlers and their families participated in our Dahlberg Gibson Learning Center early intervention program to get set for kindergarten. At the Center for Children with Disabilities, 38 students in grades Pre-K through 12 began another academic year through our on-campus Capstone Academy.



## More THRIVING

The children and adults who live in a Hattie Larlham residence experience the social and emotional benefits of living among peers and building relationships. In 2018, 357 residents grew their sense of independence and ability to make choices for themselves – all while still receiving the care they need.



## More ACHIEVING

People with intellectual and developmental disabilities are willing, able and ready to work! Hattie Larlham's employment services, work training, Summer Youth Work Experience, and Columbus-based "Transition To Work" programs together helped 285 teens and adults on their journeys to achieving their employment goals.
